

TERMS AND CONDITIONS

- i) All duties, taxes and other levies payable by the supplier under the supply contract shall be included in the total price.
- ii) Quoted prices shall be F.O.R. Mizoram University Campus, Tanhril, Aizawl.
- iii) Quotation shall remain valid for a period not less than 90 days after the deadline date specified for submission.
- iv) The bidder should enclose relevant documents wherever necessary to substantiate his/her eligibility.
- v) The quotations received from different manufacturers/brands will be evaluated based on the technical specifications of the product and quoted prices.
- vi) The contract will be awarded to the bidder whose offer is considered most acceptable technically and commercially.
- vii) Notwithstanding the above, Mizoram University reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- viii) 100% Payment shall be made only after satisfactory delivery and installation of the goods. Advance payment is not permitted.
- ix) If the successful bidder is not able to supply the goods items within the delivery date specified in the purchase order, the purchase order will be automatically treated as cancelled after expiry of delivery date period. In case of extra ordinary circumstances the vendors must send a request for extension of validity of purchase orders, with proper justification prior to the expiry of validity date for consideration.
- x) The quotation must be accompanied by catalogue/operation manuals/books etc.
- xi) Normal Commercial warranty/ guarantee shall be applicable to the supplied goods.
