

NOTIFICATION


This is for the information and compliance of all concerned that as per the resolution of the Meeting to consider COVID-19 issues and to chalk out measures to combat its possible spread in the University and its constituent College viz. Pachhunga University College, and in view of the escalated situation arising out of COVID 19 in the country, Mizoram University takes the following preventive measures with immediate effect:

1. All Classes under Mizoram University and Pachhunga University College, shall remain suspended from **17th March, 2020 to 3rd April, 2020**. Meanwhile, Academic Departments may arrange Online Tuition/study materials for students as far as practicable. If the need arises, the summer break, Saturday etc. may be utilized to compensate for the loss of days.
2. Students from within the State who are residing in the hostels are instructed to vacate hostel premises during this period. Students from outside the State are instructed not to leave the State of Mizoram as precautionary measures.
3. All meetings of Board of Studies that have been scheduled, should be conducted with local members only. Rescheduling the BoS meeting or mode of conducting the meeting shall be decided by respective Chairman of the concerned BoS.
4. All fraternity of Mizoram University are advised to refrain from travelling outside the State as far as possible. Accordingly, all leave applications to travel outside the State should be held up by granting authorities except under unavoidable circumstances.
5. All Academic Departments and Administrative Offices under Mizoram University and Pachhunga University College will remain open during this period.
6. Aforesaid measures shall be reviewed on 27th March, 2020. Further information shall be updated in the University website.
