**CORRIGENDUM**

In the Mizoram University Employment Notice vide No.1-47/Estt.I/15/560 dated 09.09.2021, the following corrigendum is issued for information and compliance of all concerned. After incorporating changes notified through this corrigendum, the detailed advertisement is duly re-uploaded in the Mizoram University website [www.mzu.edu.in](http://www.mzu.edu.in).

1. In the minimum qualifications for teaching posts under Part C, in *section (II)* for the Department of Education, in *clause 2* for Professor (Post Code - PEDNE), *sub-clause (iii)* shall be substituted as follows:

*“At least ten years of teaching experience in University Department of Education, and published work of high quality, actively engaged in research with evidence of published work in the area of his/her specialization with a minimum of ten research publications in the peer-reviewed or UGC-listed journals and evidence of having successfully guided doctoral candidate.”*

2. In the minimum qualifications for teaching posts under Part C, in *section (II)* for the Department of Education, in *clause 3* for Assistant Professor (Pedagogy in Language) (Post Code - LEDNU3), the following qualification shall be inserted:

*“Ph.D. degree in Education.”*

3. In the minimum qualifications for teaching posts under Part C, in *section (II)* for the Department of Education, in *clause 4* for Associate Professor (Post Code – REDNC & REDNU), *sub-clause (iv)* shall be substituted as follows:

*“At least eight years of teaching experience in University Department of Education or College of Teacher Education of which a minimum of three years at the M.Ed. level, and published work of high quality, actively engaged in research with evidence of published work in the area of his/her specialization with a minimum of seven research publications in the peer-reviewed or UGC-listed journals.”*

4. In the minimum qualifications for teaching posts under Part C, in *section (II)* for the Department of Education, in *clause 5* for Professor (Post Code – PEDNC & PEDNU), *sub-clause (iv)* shall be substituted as follows:

*“At least ten years of teaching experience in University Department of Education or College of Teacher Education of which a minimum of five years at the M.Ed. level, and published work of high quality, actively engaged in research with evidence of published work in the area of his/her specialization with a minimum of ten research publications in the peer-reviewed or UGC-listed journals and evidence of having successfully guided doctoral candidate.”*

5. In the minimum qualifications for teaching posts under Part C, in *section (V)* for the Department of Tourism & Hospitality Management, in *clause 1* for Assistant Professor, the following qualification shall be inserted:

*“Ph.D. degree in Tourism & Hospitality Management.”*
