GENERAL INTELLIGENCE & REASONING: The test will include questions on analogies, similarities and differences, problem solving, analysis, judgment, decision making, visual memory, relationship concepts, verbal and figure classification, arithmetical number series, non-verbal series etc. The test will also include questions designed to test the candidate's abilities to deal with abstract ideas and symbols and their relationship and other analytic functions.

PAPER-II (Descriptive):

BADMINTON:

History, Development and Organizations-India, Asia and World, Structure and Functions of controlling bodies, Terminology, Facilities and Equipment Management, Organisation of championship, tournaments and competition at different levels, Laws of Badminton.
