- These positions are meant for temporary extramural projects for appointment purely on a temporary contract basis and co-terminus with the project.
- The advertised posts are tentative without commitment for their filling. Recruitment will depend upon

 4. Age Concession: Age relaxation is admissible in respect of SC/ST/OBC candidates, Retired Government Employees, project employees, and ex-servicemen. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons, subject to the approval of the competent authority. No age relaxation will be available for the UR position.
